For Qualified Members EZ Ride Offers 50% Percent Discount for Medical Trips Thanks to a generous grant from NJ Transit, effective January 1, 2023, EZ RIDE will offer a 50% discount for medical trips provided through the EZ Ryde4Life program while funding lasts.

The membership-based "EZ Ryde4Life" program uses Lyft and Uber to provide rides for seniors without a smartphone. Seniors call EZ Ride at (201) 939-4242, option 4, to request a ride, and a Transportation Coordinator will send a Lyft or Uber car to take them where they need to go. The program is available state-wide and requires members to register, set up a transportation account using a credit or debit card, and then seniors can call when they need a ride. Riders pay the fare charged by Lyft or Uber and an administrative fee of \$2.50 per trip.

The discount is available to EZ Ryde4Life members participating in any ONE of the following programs:

- 1. Pharmaceutical Assistance to the Aged & Disabled (PAAD) Program
- 2. Senior Gold Prescription Discount Program
- 3. Beneficiary of both NJ Medicaid and Medicare programs

### **URGENT REMINDER Medicaid Unwinding**

Note: Since March of 2020, NJ FamilyCare/Medicaid has followed special rules related to the federal COVID-19 Public Health Emergency (PHE). These rules have allowed NJ FamilyCare/Medicaid members to keep their health coverage, even if they no longer qualified – for example, if their resources were above the allowable limit, which for most people with IDD, is \$2,000. However, Congress recently passed legislation that requires state Medicaid programs to go back to the rules that were used prior to the start of the COVID pandemic. This process, which is known as "Medicaid Unwinding," will last for 12 months. Therefore, each month, starting on April 1, 2023, 1/12th of the NJ FamilyCare/Medicaid beneficiaries will receive a Medicaid redetermination application. The exception to the requirement of completing a Medicaid redetermination application is individuals with IDD who receive Supplemental Security Income (SSI).

As part of this review, many members will receive mail from the State of New Jersey or their County Board of Social Services. Members will have to provide or confirm additional information so NJ FamilyCare/Medicaid can decide whether they still qualify for healthcare coverage. **Members who do not respond to NJ FamilyCare/Medicaid mail may lose their coverage.** See a <u>national summary of the data at a glance</u>, or read more about the data at <u>Medicaid.gov/unwinding-data</u>

#### Completing a Medicaid Application (A)

This may be helpful information. Medicaid services received through New Jersey's MLTSS program provide for long-term care for those who are clinically and financially eligible. Although the application itself is only a few pages long, the process is daunting and mired with pitfalls for those who have never attempted to navigate this process. Here are a few pitfalls:

Those with income exceeding \$2,742 per month must fund a Qualified Income Trust. How do most applicants discover this? By receiving a denial letter. When? Months (and thousands of dollars in nursing home fees) after applying. Gifts given within five years of applying for Medicaid create an ineligibility period. What if there was a method to resolve this unintended consequence? The Medicaid applicant's primary residence is exempt, meaning it is not counted towards Medicaid eligibility. What happens, though, if the Medicaid recipient dies while still owning the residence? What if that same Medicaid recipient has a disabled child or a child who cared for her for two years prior to filing the application? BEWARE PREDATORY PRACTICES. These are just a few of the issues that only elder law attorneys can address. However, in the past decade predatory Medicaid applications companies

have proliferated with the goal of benefitting financially from those in dire need of guidance as they face the mounting costs of long-term care. Admittedly, there are legitimate companies helping seniors qualify for Medicaid if there are no real legal issues and the application is straightforward, that's a good avenue to take. However, as soon as there is a potential hurdle: real estate, gifts, theft, a spouse, an estranged spouse, a business, or anything that may hinder eligibility; then, an attorney needs to be involved. Thankfully, the state of New Jersey is finally addressing the widespread problem of both private, non-legal companies and nursing homes themselves aiding in the Medicaid application process. Most importantly, New Jersey specifically addresses the widespread problem of nepotism in the industry. Yes, the company that you entrust to care for your loved one is also "helping" you apply for Medicaid. Think about who benefits from an arrangement where the seller of services is also advising you on how best to spend your money. Do you ask the IRS how to maximize your tax deductions? NEW JERSEY TO THE RESCUE. A bill introduced in mid-February, S-3606, would prohibit nonattorneys from charging to provide Medicaid application assistance to families. A second bill, A-5194, would require anyone providing Medicaid application assistance to disclose their relationship to the long-term care provider. These two bills aim to address an unregulated and unlicensed industry that has long been accused of financial elder abuse, consumer fraud, bad advice, and withholding money-saving advice which has cost families significant financial loss. Moreover, most of these companies have been flagrantly committing the unauthorized practice of law. # Here are the three programs that are now open:

- **Tenant-Based Rental Assistance (TBRA) Program**, which helps cover rental housing costs for low-income rental families impacted by Hurricane Ida to make rental housing more affordable.

TBRA pre-applications are available <u>online</u>. People can also request a TBRA pre-application by calling (609) 913-4252 or by emailing <u>DRM.TBRA@dca.nj.gov</u>. TBRA program staff will review pre-applications and refer households that meet eligibility criteria to complete a full application.

- Homeowner Assistance Recovery Program (HARP), which provides owner-occupied residential property owners with financial assistance to help them repair, elevate, and, in some cases, rebuild their primary homes that were damaged by Hurricane Ida.

HARP applications are available <u>online</u>. People can also request a HARP application by calling DCA's Division of Disaster Recovery and Mitigation constituent services office at (609) 292-3750 or by emailing <u>DisasterRecoveryandMitigation@dca.nj.gov</u>.

- Housing Counseling and Legal Services Program, which provides a wide range of supportive services to both renters and homeowners who were impacted by Hurricane Ida to help them recover from the storm. The services include assessing housing needs, reviewing household finances, identifying available resources, and helping people complete applications for disaster recovery programs.
