MINUTES: Minutes from the August 11, 2010 meeting.

A motion to approve the minutes of the August 11, 2010 meeting as written was made by Mr. Meltzer, seconded by Mr. DeAngelis, Vote: Meltzer, DeAngelis, Meltzer, Onembo, Blaszka, Schnorrbusch - Ayes, 0 - Nay, 0 - Abstain, motion carried.

### **DISCUSSION ITEMS:**

- Proposed Ordinance for the regulation of Windmills.
  Planner C. McGroarty reviewed the proposed ordinance for the regulation of windmills, after a brief discussion the board made the following changes to the ordinance:
  - 1. Allow in all zones (residential and nonresidential) but require minimum lot area of 5 acres.
  - 2. Approval by way of zoning permit by the Zoning Officer.
  - 3. Maximum height of tower shall be 100 feet. (This does not include blades)
  - 4. Considered abandoned if not used for 12 month period.
  - 5. Towers will be considered an accessory structure and shall not be permitted in front yard setback.
  - 6. Items #2 & 3 under Section D "Standards" will be revised to insert the term

"tower" in place of "small wind energy systems"

- 7. Item #15 under Section D"Standards" will be clarified to note that the 30 foot clearance from grade applied only to blades on a tower structure. Roof mounted systems are not subject to this standard.
- 8. Tower setback shall be 150 percent of height of tower.

PUBLIC COMMENT: No public comment was offered.

BILL LIST: A motion to approve vouchers submitted for payment was made by Mr. Sigler, seconded by Mr. Schnorrbush, all ayes motion carried.
