- 1,4 Dioxane Water Contamination Project Only two bids were received for the project as follows:
 - 1. VNL, Inc; Total Base Bid Amount \$3,655,285.00
 - 2. MSP Construction; Total Base Bid Amount \$3,378,822.25

VNL is not a certified contractor with NJAW, the apparent lowest bidder is MSP Construction. However, we only bonded for \$3,000,000 and we will have to reject the bids since they are over the appropriated amount for the project. Engineer Finelli will discuss further with the CFO and Bond Counsel to re-appropriate funds for this project.

The Easter Seals building is a slow remodel and will become a dispatch facility for a plumbing business.
