FTYA

Jim Schlessinger gave an overview of the FTYA activities and their utilization of the community center. Basketball is their main use for this center season is early November through March. Auditor Mooney advised the committee is within their rights to see financials of anyone who receives township funds such as the FTYA and Fire Department. A question as to the Port-a-johns and field paint where this expense should come out of.

CFO advised that as the numbers stand at this time, we are just under a 1 cent equivalent to \$20 increase for an average taxpayer.

Use of ARP? What can Clean Communities monies be used for? 2015 Bond Ordinance of \$150,000 for Mountain View Road for Resurfacing should be cleaned up. Auditor Mooney would like to see Debt stay level year to year. American Cares Act and American Rescue Money and COVID Money. Millbrook Road project to do or not do.

We need to bond for the Dioxane Project and confer with our Bond Attorney, asap. \$2.7 million has been allocated for this project and should be reimbursed to us within 30-60 days after the completion of the project. Attorney Benbrook is reviewing at this time a sample contract and expecting resolutions. Looking at, at least three fire hydrants.
