WORKSHOP MEETING

Budget Workshop Synopsis

The Franklin Township Committee held a Budget Workshop Meeting on Monday, January 31, 2022, at the hour of 5:00 p.m. Mayor Mike Toretta opened the meeting in accordance with the "Open Public Meeting Act" Chapter 231, P.L. 1975 having been duly advertised and a copy posted in the office of the Township Clerk.

ROLL CALL OF COMMITTEE MEMBERS: Butler-Yes, Ferri-Yes, Guth-Yes, Herzer-Yes; Toretta-Yes. (5) Present; (0) Absent

Present were: Joe Biel, DPW Foreman and Brandon Lisa, Road Laborer I, Raymond Read, OEM, Jan Verkade, Fire Chief, Denise L. Becton, Municipal Clerk.

The committee reviewed the department and employee wish lists submitted.

Fire Department/EMS

Chief Verkade attending this evening submitted the 2022 Fire and EMS Division Budget Requests. Chief Verkade advised for the Fire Department budget money is needed for PPE (Personal Protective Equipment), turn out gear, service and repairs on trucks and equipment, pumps, replace some fire hose and nozzles. A total budget request for fire division \$57,900. EMS division, 924 calls in 2021. Request for COVID related supplies, equipment repair, medical supplies, EMS training and Electronic EMS Charting annual state mandated charting software fee. A total request for EMS Division \$21,680. Workers Compensation reimbursement initial physicals discussed for new members.

OEM

OEM Read informed a replacement for DOEM will be needed since DOEM Becton will be resigning effective March 31, 2022.

DPW

A discussion ensued with Brandon Lisa and Joe Biel as to enrollment into the State Health Benefits Plan, the cost out of employee's pocket Direct 10 vs Direct 15. Looking for accurate numbers per paycheck and the statutory payroll deduction for health/dental insurances. Also, looking to receive their dental/health insurance cards for doctor visits. The township committee conferenced called the CFO into this meeting to assist with this matter at 5:31 pm. CFO informed the deduction from your paycheck is based on your salary and the plan you choose. The CFO will have our Auditor John Mooney recalculate the figures to compare. At approximately 5:50 pm CFO disconnected from the meeting.

The DPW is looking to increase their boot allowance and purchase winter jackets instead of renting, as this will save money. Joe Biel is now a certified CPWM, and individual letters received for salary increase consideration.

A minor accident with one of our plow trucks and a vehicle running a red light, ripping our plow off the truck has been submitted to the insurance company.

Open Space/Recycle/Office Assistant

The positions of the Open Space Secretary and Recycle Coordinator will need to be filled and a job description will be needed to be created to hire an Office Assistant for 2 days a week and 7 hours a day to assist the Municipal Clerk effective March 31st due to retirement.
