The Dioxane Water Main Project is moving forward. The Resolutions previously adopted, and Ordinance 2022-5 adopted this evening will be executed/certified and sent to the state. Attorney Benbrook spoke with our bond counsel about getting the funding in place for this project.

Shurts Road – NRCS Grant Project is moving forward.

Montana Road Retaining Wall Repair – The contractor expects to start this project in a couple of weeks.

Attorney Benbrook informed the committee that the two pending litigations are still ongoing. He is still working on a new "Draft" to update our Personnel Policy.

The EMAA Grant submitted on 4/9 is in the first step process.

#### DPW REPORT - Joe Biel - report submitted on file

A discussion in reference to the work at 105 Good Springs Road. Contractor Bartha is backed up from completing this job and has been in contact with the homeowner as to the grading. Once the repairs have been satisfied the homeowner will be advised of the cost out of pocket from the contractor and our DPW.

## **Township Committee Reports:**

### **Bonnie Butler-**

Has another name of a solar company as to leasing township property. Met with Foreman Biel and Laborer Tampier at the New Village Field as to a potential walking path. Figures of \$19,000 for 4" of black top over QP, \$1,300 weekly machine rental, fence \$11,000 through Co-op. Previously the Lions Club mentioned donation of money for playground equip. A cost of \$38,300 for material/installation and there is plenty of money in the Open Space and Recreational Trust Fund. This would be a total asset to our community. Posting of no pets, dusk to dawn, and include 6 stone parking spaces on Third Street. A concern was raised as to how many kids are in the area that would use this and who will police it. Poll the residents in the vicinity to see if there would be an interest. Discussions to continue.

## Community Center - Eddy Patient-report submitted and on file

After meeting with Mayor Toretta and was informed of the committee's concerns with the community center. Rental fees for 2022 have been increased by 10% for non-FTYA groups and will net and extra \$3-4,000 this year. Next year an additional 10% again to non-FTYA groups will be applied. There is still a concern as the intended use of this building as a warehouse and the septic system. Eddy spoke with Delaware Valley Septic, and they will have portable toilets to alleviate heavy septic use, only allowing daytime groups the availability the use of our restrooms during normal daytime municipal hours.

## RESOLUTION 2022-39 SELF-EXAMINATION OF BUDGET RESOLUTION

WHEREAS, N.J.S.A. 40A:4-78b has authorized the Local Finance Board to adopt rules that permit municipalities in sound fiscal condition to assume the responsibility, normally granted to the Director of the Division of Local Government Services, of conducting the annual budget examination; and

WHEREAS, N.J.A.C. 5:30-7 was adopted by the Local Finance Board on February 11, 1997; and

WHEREAS, pursuant to N.J.A.C. 5:30-7.2 through 7.5, the Town of Belvidere has been declared eligible to participate in the program by the Division of Local Government Services, and the Chief Financial officer has determined that the local government meets the necessary conditions to participate in the program for the 2022 budget year.

NOW THEREFORE BE IT RESOLVED by the governing body of the Township of Franklin, Warren County, that in accordance with N.J.A.C. 5:30-7.6a & 7.6b and based upon the Chief Financial Officer's certification, the governing body has found the budget has met the following requirements:

- 1. That with reference to the following items, the amounts have been calculated pursuant to law and appropriated as such in the budget:
  - a. Payment of interest and debt redemption charges
  - b. Deferred charges and statutory expenditures
  - c. Cash deficit of preceding year
  - d. Reserve for uncollected taxes
  - e. Other reserves and non-disbursement items
  - f. Any inclusions of amounts required for school purposes.
- 2. That the provisions relating to limitation on increases of appropriations pursuant to N.J.S.A. 40A:4-45.2 and appropriations for exceptions to limits on appropriations found at N.J.S.A. 40A:4-45.3 et seq., are fully met (complies with CAP law).
- 3. That the budget is in such form, arrangement, and content as required by the Local Budget Law and N.J.A.C. 5:30-4 and 5:30-5.
  - 4. That pursuant to the Local Budget Law:
    - a. All estimates of revenue are reasonable, accurate and correctly stated,
    - b. Items of appropriation are properly set forth
    - c. In itemization, form, arrangement and content, the budget will permit the exercise of the comptroller function within the municipality.
- 5. The budget and associated amendments have been introduced and publicly advertised in accordance with the relevant provisions of the Local Budget Law, except that failure to meet the deadlines of N.J.S.A. 40A:4-5 shall not prevent such certification.
- 6. That all other applicable statutory requirements have been fulfilled.

BE IT FURTHER RESOLVED that a copy of this resolution will be forwarded to the Director of the Division of Local Government Services upon adoption.
