At this time, the committee addressed Tax Collector, Karin Kneafsey and the Tax Office procedures and Corrective Action Plan. Committeeperson Butler addressed the problem with the reconciliation of cash books with online tax payments. The township has paid to date \$5,000 out of pocket to auditors to reconcile said books. The deposits are not reflective when posted based on email receipts for online deposits to the tax collector's office and the problem with Municipay needs to be corrected. Ms. Kneafsey informed that she has gone through the first three months of bank statement. Deposits will have to be posted individually was suggested by the auditor in hopes to rectify this problem. Ms. Kneafsey will also prepare an excel spreadsheet to itemize tax monies

#### REPORTS/UPDATES

#### Engineer -

Dioxane Water Project – no update from DEP since July 1<sup>st</sup> and moving forward to complete the contract. Montana Road Project – target date of next week for contractor to start the work, should take no more than two weeks to complete. Shurts Road Project – The bid opening was July 6<sup>th</sup> and upon recommendation by the engineer to award the project to Samson Concrete Masonry with a Base Bid of \$208,309 and Alternate Bid of \$42,000 for roadway restoration. However, upon suggestion of Engineer Finelli not to award the Alternate Bid as our DPW could restore the roadway after the project is completed. Engineer will also proceed to file an extension through the NRCS as the deadline to complete the project moves closer of August 24, 2022.

Mayor Toretta questioned the out-of-pocket expense with the shortfall of the grants already received for Millbrook Road Phase I and Phase II. Committeeperson Herzer concurs with mayor that the road doesn't need repair at this time and Foreman Biel informed that the structure of the road is in good shape. Engineer Finelli advised that Millbrook Road was a good candidate to make an application with the NJDOT. Recommendation to delay the project to do next year and apply through the DOT for Phase III in hopes to reduce out of pocket expense for the township. However, if the committee is still not in consensus to move forward with this project, they can still decline the grants.

A letter of support to have the governor sign Senate Bill S2732 and Assembly Bill A4089 was drafted for the mayor to sign.
