WHEREAS, the outside contractor, for Franklin Township, Warren County, NJ caused the debris, brush, and noxious growth to be removed; and

WHEREAS, the outside contractor, for Franklin Township, Warren County, NJ has certified to the Mayor and Committee the cost of the removal of the debris, brush and noxious growth.

THEREFORE, BE IT RESOLVED, BY THE MAYOR AND COMMITTEE OF THE TOWNSHIP OF FRANKLIN, AS FOLLOWS:

1. The certification of the costs of removal of the debris, brush and noxious growth has been examined and found to be correct.

2. Engineer Report – No formal Report submitted:

Engineer Finelli briefed the committee as to a few projects this month. The 2018 NJDOT Grant for Stewartsville Road is on hold. The 2019 NJDOT Grant for Montana Road is going through and some of the work being completed by our DPW. The 2020 NJDOT Grant, applications are to be submitted by July 19th and will be for the balance of Montana Road. Attorney Report – Report on file

Attorney Benbrook mailed a letter to the Mayor of Washington Township addressing the closure of Mountain View Road East by their police department. Another letter was sent to Tractor Supply Corporate Office in reference to the freezing of our township account. It appears that the pending unpaid charges on the account are from another municipality in Vineland, NJ, hoping to rectify the situation soon. The township and our Land Use Board are being sued with the Redevelopment Designation. Now that we are in litigation no further public discussion.

Mr. Onembo informed the committee as to active zoning and code enforcement this past month. Our township contractor is managing our vacant/abandoned properties for high grass and removal of debris, a continuous problem. Candy's has a major septic issue. 8 Wolverton Road dealt with an issue of recreational flying vehicles. An interest in the previous Broadway Bank building. The Sign and Bamboo Ordinances need to be addressed.
