NEW BUSINESS

NJSP – no representation or report

OLD BUSINESS

The municipal budget will not be introduced this evening. At this time, the proposed budget, the average household of 200,000, is looking at an average increase of approximately \$75. The consensus of the committee is not to increase the taxes, but, we need to see if there are areas available to cut, and without ratables the burden is on our residence. We could be looking at possible layoff of employees and no consideration of employee raises. The Litigation line item went from \$26-\$40,000. Our municipal court contract will dissolve at the end of the year, looking to contract with a neighboring municipality. Additional discussions and possible introduction to ensue in June.

REPORTS/UPDATES:

Engineer Report – No formal report submitted this month

Engineer Finelli updated the committee as to the Montana Road, Sections I&II DOT Grants. Beidleman Road, Habitat Homes, approvals have been given for two driveway permits.

A motion was made by Rich Herzer and seconded by Mike Ferri authorizing the CFO to appropriate a total of \$23,000 from the Affordable Housing Trust Fund, subject to receiving executed vouchers, to WC Habitat for Humanity.

A refund of approximately \$5,000 has been processed for Stormwater Management Works. Due to new Regulations by NJDEP, our Stormwater Ordinance will have to be amended accordingly. The Stewartsville Road Project has been shut down at this time and will revisit the road conditions once they re-mobilize.

Attorney Report - No formal report submitted

Attorney Benbrook informed that the filing deadline for Financial Disclosure Statements has been extended to July 31st.

Beth Barry - Open Space Commission

Ms. Barry advised the committee that the Outreach Mailing has not been mailed out yet by The Land Conservancy. The WC Open House has been canceled.

Fire Department/OEM - Raymond Read

Chief Read informed that the department has been super busy with 314 calls to date, including 83 transports of possible COVID cases, 54 confirmed. An ambulance is on stand by at the WC testing center Tuesday and Fridays. Five members have been quarantined and one member has been confirmed contracting COVID-19. Fundraising will be challenging this year, and might take a big hit financially. The department purchased a Decontamination Machine and has been used to spray the municipal offices, DPW garage as well as the fire/ems stations and apparatus. Noting an ambulance is disinfected after each emergency call. The Chief thanked his members, providing great service without hesitation. Mayor DeAngelis also thanked Chief Read and his members for all they do.

Jim Onembo - Code Enforcement/Zoning-

Mr. Onembo informed that a lot of building is taking place in the township. Two new foreclosures have been received and since January, \$42,000 has been collected/deposited for vacant property registration fees. Attorney Benbrook will work with Mr. Onembo as to certified liens in reference to 26 VanSyckle Road. Engineer Finelli will look into the Weiner property.

An extensive conversation evolved as to the contaminants/dioxane in the drinking water on Willow Grove Road. Mayor DeAngelis will look into this matter and will notify residents as to the concern of dioxane and a testing lab. Ms. Barry offered the assistance of the Open Space Commission to help in any way possible.

Rick Canale spoke about ultralights in the area of Woolverton Road. Motors are loud and are a nuisance. Mayor informed him to look for notification when/if application to be heard in front of our Land Use Board.

Chief Read informed that ISE Farms donated 1500 Tyvek suits to their department. Fire/EMS kept 500 donating the remainder to WCOEM.

At this time the floor was closed to Public Session 8:59 pm.
